Our X Block Expungement Program solicits funds from the general public and seeks to offer Expungement Events around the state until we are able to deploy the program nationally. Our nonprofit also actively seeks out assistance from organizations, whom have donated or sponsored programs and events, in an effort to spread our random acts of kindness in a collaborative and positively engaging way. Our organization also has a governing board of directors whom actively fund, participate and facilitate programs that benefit the public. We host Expungement Events, Community Clean-Ups, Disaster-Preparedness Relief and Emergency Assistance along with Pizza and Snoball Days, creating buzz around educational/school programs for higher student engagement, concentration and excellment along with many other activities all designed to spread positivity.

Reasonable Cause Explanations

Explanation

We were late filing this return for the same reason as the previous returns. We were not aware that our 501(c)(3) nonprofit had to file a tax return with the IRS each year, we thought we had to do check-ins every few years if there was no change in the profit, revenues or expenses that much for the nonprofit. We now know we need to file each year and ensure that our state receives a copy of our return to place on file in our records.

Primary Exempt Purpose

RAX Worldwide's primary exempt purpose is to fundraise enough monetary support or receive donations to sponsor giveaways, contribute to job creation, community development, fundraisers, special events, budget building, expansion and to incorporate programs as part of our effort such as Trash is Treasure, Disaster Relief/Relocator, Refining Generations - Etiquette Classes, and Expansion League.
